RESOLUTION APPROVING \$78,036.00 OF ADDITIONAL FUNDS FOR THE PURCHASE OF BALLISTIC PERSONAL PROTECTIVE SYSTEMS FOR THE POLICE DEPARTMENT, FOR A TOTAL ESTIMATED ANNUAL AMOUNT OF \$198,036.00

WHEREAS, the Police Department has requested the Finance Department’s Procurement Division to issue a purchase order for the purchase of ballistic personal protective systems utilizing the NASPO ValuePoint Agreement #164720 and the State of Iowa Participating Addendum #MA21235; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder; and

WHEREAS, on August 8, 2022, by Roll Call #22-1276, the City Council approved the purchase from Streicher’s Inc., 10911 W Highway 55, PO Box 41398, Minneapolis, MN 55441 (Jeremy Jenniges, President) and Galls LLC, 1340 Russell Cave Rd., Lexington, KY 40505 (R. Michael Andrews, CFO) and authorized expenditures at an annual estimated amount of \$120,000.00 from the general operating fund and the 2022 Byrne Justice Assistance Grant; and

WHEREAS, an additional spending in the amount of \$78,036.00 is anticipated for the remainder of the fiscal year for the purchase of ballistic plates and the complete personal protective systems utilizing the NASPO Value Point Agreement #134720 and the State of Iowa Participating Addendum #MA21235; and

WHEREAS, \$78,036.00 of additional funding is available from the 2022 Byrne Justice Assistance Grant and asset forfeiture funds.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the additional expenditure of \$78,036.00, with a total estimated annual amount of \$198,036.00 for the purchase of ballistic personal protective systems for the Police Department as described above, is hereby approved.
