## SET HEARING FOR APPROVAL OF A LICENSE AGREEMENT WITH LICENSE AGREEMENT WITH THE DES MOINES AREA REGIONAL TRANSIT AUTHORITY (DART) FOR BUS BENCHES IN STREET RIGHT-OF-WAY

WHEREAS, the City of Des Moines (City) contract with Creative Outdoor Advertising of America (COA) for bus benches, bench pads and related advertising services in the City right-of-way ended on September 30, 2022; and

WHEREAS, Des Moines Area Regional Transit Authority (DART) would like to continue to provide bus stop amenities by initially installing ten (10) replacement benches at some of the locations as the COA benches are removed; and

**WHEREAS**, the Manager's Office for the City has negotiated a License Agreement (Agreement) with DART for the placement of bus benches, and in certain locations, concrete pads and trash receptacles in the City right-of-way, which Agreement will include, among other terms, the following:

- a twenty (20) year term;
- a one-time lump sum payment of One Hundred Dollars (\$100.00), which amount reflects that the proposed use is mutually beneficial to the City and to DART;
- the right of either party to terminate the Agreement prior to the end of the fixed license term upon three hundred sixty-five (365) days written notice to the other party;
- acknowledgement and acceptance by both City and DART of the mutual indemnification obligations provided for in Attachment 1 of the Agreement, "Real Estate License Major, Insurance and Indemnification Requirements"; and

**WHEREAS,** DART benches are currently planned to be placed at the following locations with DART reserving the right to add bench locations to the Agreement based on ridership, feasibility, and available funding:

- University Avenue and 2nd Avenue, Westbound
- 6th Avenue and Holcomb Avenue, Southbound
- E. 14th Street and Walker Street, Southbound
- Hubbell Avenue and E. 38th Street, Eastbound
- E. 30th Street and Walker Street, Southbound
- E. Army Post Road and Se 5th Street, Westbound
- E 33rd Street and E. University Avenue, Southbound
- Indianola Avenue and SE 14th Street, Southbound
- Woodland Avenue and 12th Street (far side), Westbound
- Locust Street and 9th Street, Eastbound
