## APPROVAL OF DEVELOPMENT AGREEMENT WITH OPENLOOP HEALTH, INC.

WHEREAS, on January 9, 2023, by Roll Call Number 23-0038, the City Council approved a resolution in support of an application for economic assistance between OpenLoop Health, Inc., the Iowa Economic Development Authority (IEDA), and the City of Des Moines under the IEDA's High Quality Jobs Program for a forgivable loan in the amount of \$250,000 as a local match to support the expansion of OpenLoop Health, Inc's existing headquarters within downtown Des Moines ("Project"); and

WHEREAS, the Project has received approval from the Iowa Economic Development Authority (IEDA); and

WHEREAS, the Project will create 400 new jobs, 60 of which are anticipated to meet or exceed the state's High Quality Jobs wage threshold for Polk County of \$34.25 per hour, or \$71,240 annually; and

WHEREAS, City staff has negotiated a development agreement providing OpenLoop Health, Inc. with a forgivable loan an one-time upfront lump sum of \$250,000, which loan will be forgiven after a three year benchmark only if OpenLoop, Inc. meets certain renovation, lease, and job targets; and

WHEREAS, in the event OpenLoop Health, Inc. does not meet all benchmark targets, the development agreement requires payment to the City within thirty days' written notice.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The development agreement with OpenLoop Health, Inc., is hereby approved in the material form as attached to this roll call (the "Agreement").
- 2. The City Manager or his designee are authorized to negotiate non-substantive changes to specific terms of the attached Agreement subject to approval as to form by the Legal Department.
- 3. Any material changes to the Agreement, as determined by the City Manager, must be submitted to the City Council for additional review and approval.
- 4. Upon execution by Developer and approval by the Legal Department as to form, the City Manager is hereby authorized and directed to sign the Agreement.
- 5. Upon execution of the Agreement by the City Manager, the City Manager or his designees are hereby authorized and directed to administer the development agreement on behalf of the City, and to monitor compliance by the Developer with the terms and conditions of the Agreement.
- 6. Upon requisition by the Office of Economic Development, the Finance Department shall advance the Economic Development Assistance pursuant to the Agreement.
