RESOLUTION RELEASING SUBDIVISION BOND FOR SOUTHWOODS ESTATES PLAT 1

WHEREAS, on June 24, 2019, by Roll Call Number 19-0986 the City Council approved the subdivision bond for the development entitled Southwoods Estates Plat 1, located at 3800 SW 56th Street, to be developed by TK Development, LLC, Dan Kruse, Manager, and accepted bond number NIA2536 from Merchants Bonding Company, to secure the satisfactory completion and payment of the required sidewalk improvements; and,

WHEREAS, on May 10, 2021, by Roll Call Number 21-0682 the City Council reduced the amount of security required for such improvements from \$115,348 to \$28,837 as security for the remaining subdivision improvements; and,

WHEREAS, the City Engineer has certified that the sidewalk improvements have been completed and recommends that the security be released;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That Subdivision Bond number NIA2536 in the amount of \$28,837 from Merchants Bonding Company, is hereby released as security for the satisfactory completion of the sidewalk improvements.
