AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1811, 114-2629, 114-2630, and 114-2631, 114-3245, 114-3246, and 114-3247 and repealing Section 114-1944, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1811, 114-2629, 114-2630, and 114-2631, 114-3245, 114-3246, and 114-3247 and repealing Section 114-1944, relating to traffic and vehicle regulations, as follows:

## Sec. 114-1811. Grand Avenue.

Grand Avenue, from Third Street Fifth Avenue to Eighteenth Street, westbound.

# Sec. 114-1944. Repealed by Ord. No. --,--Fifth Avenue.

Fifth Avenue, from Grand Avenue to Court Avenue, southbound, except that the portion from Locust Street to Walnut Street, shall be a two-way street.

#### Sec. 114-2629. Fifth Avenue-Court Avenue to Walnut Street.

Fifth Avenue, on the east side, from Court Avenue Mulberry Street to Walnut Street, no parking any time.

Fifth Avenue, on the west side, from Mulberry Street to a point 90 feet south thereof, no parking any time.

Fifth Avenue on the west side, from Mulberry Street to a point 50 feet south thereof, no parking any time.

Fifth Avenue, on the west side, from a point 90 feet south of Mulberry Street to a point 15 feet south thereof, no parking any time.

Fifth Avenue, on the west side, from Mulberry Street to Walnut Street, no parking any time.

#### Sec. 114-2630. Fifth Avenue--Walnut Street to Locust Street.

Fifth Avenue, on the east side, (southbound median), from Walnut Street to a point ten feet north thereof, no parking any time.

Fifth Avenue, on the east side, (southbound median), from Locust Street to a point fifteen feet south thereof, no parking any time.

Fifth Avenue, on the east side, (southbound median), from a point 95 feet north of Walnut Street to a point 100 feet north thereof, commercial loading zone, 8:00 a.m. to 6:00 p.m.

Fifth Avenue, on the west side, (southbound), from a point 140 feet north of Walnut Street to a point 90 feet north thereof, no parking any time.

Fifth Avenue, on the west side, from Locust Street to a point 30 feet south thereof, no parking any time.

Fifth Avenue, on the west side, from Walnut Street to a point 30 feet north thereof, no parking any time.

Fifth Avenue, on the east side, (northbound <u>frontage street</u>), from Walnut Street to a point 125 feet north thereof, loading zone, 8:00 a.m. to 6:00 p.m. No stopping 6:00 p.m. to 8:00 a.m.

Fifth Avenue, on the east side, (northbound <u>frontage street</u>), from a point 125 feet north of Walnut Street to Locust Street, no parking any time.

Fifth Avenue, on the west side (northbound —<u>medianfrontage street</u>), from Walnut Street to Locust Street, no parking any time.

Fifth Avenue, on the west side from Walnut Street to Locust Street, no parking any time.

## Sec. 114-2631. Fifth Avenue--Locust Street to Grand Avenue.

<u>Fifth Avenue</u>, on the east side, from a point 25 feet south of Grand Avenue to a point 35 feet south thereof, loading zone.

<u>Fifth Avenue</u>, on the west side, from Locust Avenue to Grand Avenue, no parking any time.

Fifth Avenue, on the east side, from Locust Street to Grand Avenue, no parking any time. Fifth Avenue, on the west side, from Locust Street to a point 26 feet north thereof, no parking any time.

Fifth Avenue, on the west side, from a point 90 feet north of Locust Street to a point 75 feet north thereof, no parking any time.

Fifth Avenue, on the west side, from a point 25 feet south of Grand Avenue to a point 45 feet south thereof, commercial loading zone.

Fifth Avenue, on the west side, from Grand Avenue to a point 25 feet south thereof, no parking any time.

Fifth Avenue, on the west side, from Locust Street to Grand Avenue, no parking any time.

#### Sec. 114-3245. Grand Avenue-Second Avenue to Third Street.

Grand Avenue, on the south side, from Second Avenue to a point 45 feet west thereof, no parking any time.

Grand Avenue, on the south side, from a point 45 feet west of Second Avenue to a point 27 feet west thereof, is designated a handicapped loading zone, 30-minute limit, and is subject to the same prohibitions as are found in subsection 114-616(a) and section 114-608 of this chapter.

Grand Avenue, on the south side, from a point 72 feet west of Second Avenue to a point 114 feet west thereof, loading zone.

Grand Avenue, on the south side, from a point 186 feet west of Second Avenue to Third Street, no parking any time.

Grand Avenue, on the north side, from Third Street to a point 70 feet east thereof, no parking any time.

## Sec. 114-3246. Grand Avenue-Third Street to Fourth Street.

Grand Avenue, on the south side, from a point 170 feet west of Third Street to Fourth Street, no parking any time.

Grand Avenue, on the north side, from Third Street to <u>Fourth Streeta point 15 feet west thereof</u>, no parking any time.

Grand Avenue, on the north side, from a point 15 feet west of Third Street to a point 30 feet west thereof, commercial loading zone, 9:00 a.m. to 4:00 p.m., Monday through Friday.

Grand Avenue, on the north side, from Third Street to Fourth Street, no parking 7:00 a.m. to 9:00 a.m.

Grand Avenue, on the north side, from Third Street to Fourth Street, no parking 4:00 p.m. to 6:00 p.m.

## Sec. 114-3247. Grand Avenue--Fourth Street to Fifth Avenue.

Grand Avenue, on the south side, from Fourth Street to a point 100 feet east of Fifth Avenue, no parking any time.

Grand Avenue, on the south side, from Fifth Avenue to a point 65 feet east thereof, loading zone.

Grand Avenue, on the south side, from a point 65 feet east of Fifth Avenue to a point 35 feet east thereof, handicapped loading zone, 30-minute limit, subject to the special identification device and use restrictions found in subsection 114-616(a) of this chapter.

Grand Avenue, on the north side, from Fourth Street to Fifth Avenue, no parking 7:00 a.m. to 9:00 a.m.

Grand Avenue, on the north side, from Fourth Street to Fifth Avenue, no parking 4:00 p.m. to 6:00 p.m.

Grand Avenue, on the north side, from a point 25 feet east of Fifth Avenue to a point 45 feet east thereof, commercial loading zone, 9:00 a.m. to 4:00 p.m., Monday through Saturday.

Grand Avenue, on the north side, from Fifth Avenue to a point 25 feet east thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
