**SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF EXCESS CITY PROPERTY LOCATED AT THE CORNER OF EAST WASHINGTON AVENUE AND DEWOLF STREET TO JACKSON CONTRACTING, LLC FOR \$30,500**

**WHEREAS**, the City of Des Moines, Iowa, (“City”) is the owner of certain excess real estate located at the corner of East Washington Avenue and DeWolf Street, Des Moines, Iowa, locally known as Geoparcels 792436277007, and 1611 DeWolf Street (hereinafter collectively “Property”), more particularly described below; and

**WHEREAS**, Jackson Contracting, LLC has offered to the City of Des Moines, Iowa, the purchase price of \$30,500.00 for the purchase of said Property in order to redevelop the property with a commercial transportation sign business, which price reflects the fair market value as determined by the City’s Real Estate Division; and

**WHEREAS**, the City has no known current or anticipated public need for the Property proposed to be sold and the City will not be inconvenienced by the sale of said Property.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa, proposes to sell certain City of Des Moines real estate located at the corner of East Washington Avenue and DeWolf Street, Des Moines, Iowa and locally known as Geoparcels 792436277007, and 1611 DeWolf Street, as legally described, to the grantees, and for the consideration identified below, subject to the terms contained in the Offer to Purchase, and further subject to a reservation of easements therein, and further subject to a no-build easement over 1611 DeWolf Street, which easement will be included in the Quit Claim Deed from City to Buyer:
