SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF A PORTION OF EXCESS CITY PROPERTY LOCATED EAST OF AND ADJOINING 1700 SCOTT AVENUE TO C & C REALTY, LLC FOR \$25,640

WHEREAS, on December 17, 2018 by Roll Call 18-2110 the City Council of the City of Des Moines, Iowa approved a Land Exchange Agreement with Hawkeye Land Co. whereby the City acquired a Temporary Easement for Construction, a portion of vacated Market Street within the Market District and a vacant parcel located east of and adjoining 1700 Scott Avenue, Des Moines; and

WHEREAS, C & C Realty, LLC, 1700 Scott Avenue, Des Moines, Iowa, has offered to the City of Des Moines ("City") the purchase price of \$25,640.00 for the purchase of the vacant parcel located east of and adjoining its property at 1700 Scott Avenue (hereinafter "Property"), for assemblage with 1700 Scott Avenue, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Property proposed to be sold, and the City will not be inconvenienced by the sale of said Property.


