AN ORDINANCE continuing and expanding the boundaries of the Downtown Des Moines Self-Supported Municipal Improvement District pursuant to the provisions of Chapter 386, Code of Iowa, and providing for the continuation of an operation fund and the levy of an annual tax in connection therewith.

WHEREAS, the City of Des Moines is authorized by Chapter 386, Code of Iowa (the "Act") to create a self-supported municipal improvement district in the City, to provide for the existence and operation of such district, to provide for improvements or self-liquidating improvements for such district, and to levy taxes with respect to such district, all as more specifically defined in the Act; and,

WHEREAS, Ordinance No. 13,579 passed by the City Council on February 23, 1998 established the Downtown Des Moines Self-Supported Municipal Improvement District pursuant to the provisions of the Act and provided for the establishment of an operation fund and the levy of an annual tax in connection therewith; and,

WHEREAS, Ordinance No. 13,913 passed by the City Council on January 22, 2001, continued the Downtown Des Moines Self-Supported Municipal Improvement District pursuant to the provisions of the Act and provided for the continuation of an operation fund and the levy of an annual tax in connection therewith; and,

WHEREAS, Ordinance No. 14,311 passed by the City Council on January 26, 2004 continued and expanded the Downtown Des Moines Self-Supported Municipal Improvement

District pursuant to the Act and provided for the continuation of the operation fund and the levy of an annual tax in connection therewith until June 30, 2009; and,

WHEREAS, Ordinance No. 14,540 passed by the City Council on February 6, 2006 expanded the Downtown Des Moines Self-Supported Municipal Improvement District pursuant to the Act and provided for the continued levy of an annual operation tax on property in the expanded District; and,

WHEREAS, Ordinance No. 14,834 passed by the City Council on February 23, 2009 continued the Downtown Des Moines Self-Supported Municipal Improvement District pursuant to the Act and provided for continuation of the operation fund and levy of an annual tax in connection therewith until June 30, 2014; and,

WHEREAS, Ordinance No. 15,218 passed by the City Council on September 23, 2013 continued and adjusted the boundaries of the Downtown Des Moines Self-Supported Municipal Improvement District pursuant to the Act and provided for continuation of the operation fund and levy of an annual tax in connection therewith until June 30, 2019; and,

WHEREAS, Ordinance No. 15,700 passed by the City Council on September 10, 2018 continued the Downtown Des Moines Self-Supported Municipal Improvement District pursuant to the Act and provided for continuation of the operation fund and levy of an annual tax in connection therewith until June 30, 2024; and,

WHEREAS, a petition (the "Petition") has been filed with the City Clerk pursuant to the Act petitioning the City Council to continue and expand the boundaries of the Downtown Des Moines Self-Supported Municipal Improvement District (the "District"), to continue an operation fund with respect to the District, and to levy an annual tax for such fund, all for the purposes of paying the administrative expenses of improvements or self-liquidating improvements with respect to the District; and,

WHEREAS, the Petition is in all ways in complete compliance with the provisions of the Act; and,

WHEREAS, on May 22, 2023, by Roll Call No. 23-0741, the City Council received the Petition and referred it to the City Plan and Zoning Commission for review in accordance with the Act; and,

WHEREAS, on June 26, 2023, by Roll Call No. 23-0903, the City Council received the report of the City Plan and Zoning Commission on the merits and feasibility of the continuation and expansion of the District; and,

WHEREAS, on June 26, 2023, by said Roll Call No. 23-0902 the City Council scheduled a public hearing for July 17, 2023, at 5:00 P.M., at which it proposed to take action for the

continuation and expansion of the District, and did direct that notice of such hearing be given in accordance with the Act; and,

WHEREAS, notice of the hearing was mailed by certified mail on June 26, 2023, to all the owners of record of real property located within the District as shown by the records of the Polk County Auditor, and a copy of the notice was published in the Des Moines Register on July 5, 2023, in satisfaction of the notice requirements of the Act; and,

WHEREAS, at the aforementioned time and place, the City Council did meet and hear all owners of property in the District and residents of the City desiring to express their views with respect to the continuation and expansion of the District; and,

WHEREAS, on July 17, 2023, by Resolution and Roll Call No. 23-1042, the City Council closed the public hearing on the continuation and expansion of the District and found that the Petition, the District satisfied the applicable requirements imposed by the Act; and,

WHEREAS, more than thirty days has now passed since the public hearing on the continuation and expansion of the District was closed, and no petition has been filed with the City Clerk opposing the continuation and expansion of the District.

NOW THEREFORE, BE IT ORDAINED, by the City Council of the City of Des Moines, Iowa:

Sec 1. That in accordance with Iowa Code Chapter 386 and the recitations set out in the Preamble hereof the self-supported municipal improvement district as defined in the Act, named the "Downtown Des Moines Self-Supported Municipal Improvement District" (the "District") established and created in the City of Des Moines pursuant to Ordinance No. 13,579, continued pursuant to Ordinance No. 13,913, continued and expanded pursuant to Ordinance No. 14,311, further expanded pursuant to Ordinance No. 14,540, continued pursuant to Ordinance No. 14,834, continued with adjusted boundaries pursuant to Ordinance No. 15,218, and continued pursuant to Ordinance No. 15,700, is hereby further continued and expanded in accordance with the general terms of the Petition.

Sec. 2. The District shall consist of all the property within the following described boundaries:

BEGINNING AT THE INTERSECTION OF THE SOUTH RIGHT OF WAY LINE OF EAST MARTIN LUTHER KING JR PARKWAY AND THE CENTERLINE OF THE SOUTHEAST 7TH STREET RIGHT OF WAY; THENCE WESTERLY ALONG SAID SOUTH RIGHT OF WAY OF EAST MARTIN LUTHER KING JR PARKWAY TO THE NORTHEASTERLY EXTENSION OF THE NORTHWEST LINE OF BLOCK 8 IN SCOTT & DEAN'S ADDITION, AN OFFICIAL PLAT; THENCE SOUTHWEST ALONG SAID NORTHWEST

ALSO SAID POINT BEING ON THE CENTERLINE OF THE PLATTED SCHOOL STREET RIGHT OF WAY; THENCE EAST AND PARALLEL TO THE NORTH LINE OF SAID BLOCK G TO THE NORTHERLY EXTENSION OF THE WEST RIGHT OF WAY LINE OF 2ND AVENUE; THENCE SOUTHEASTERLY ALONG A STRAIGHT LINE TO THE NORTHWEST CORNER OF BLOCK H IN SAID RIVER HILLS PLAT ONE; THENCE EAST ALONG THE NORTH LINE OF SAID BLOCK H, A DISTANCE OF 37 FEET TO A CORNER OF SAID BLOCK H; THENCE NORTHEASTERLY ALONG A STRAIGHT LINE TO A POINT THAT IS 48 FEET NORTH OF AND 290 FEET EAST OF THE PREVIOUS STATED CORNER OF SAID BLOCK H: THENCE EAST ALONG A STRAIGHT LINE TO THE NORTHWEST CORNER OF RIVER HILLS PLAT THREE, AN OFFICIAL PLAT: THENCE EASTERLY ALONG THE NORTHERLY LINE OF SAID RIVER HILLS PLAT THREE TO THE NORTHEAST CORNER OF BLOCK B IN SAID RIVER HILLS PLAT THREE: THENCE SOUTH ALONG THE WEST LINE OF EAST FORT DES MOINES, AN OFFICIAL PLAT, TO THE NORTHEASTERLY LINE OF PARCEL DEEDED BY THE CITY OF DES MOINES AND RECORDED IN BOOK 10987 PAGE 783 AT THE RECORDER'S OFFICE OF POLK COUNTY, IOWA; THENCE SOUTHEAST ALONG SAID NORTHEASTERLY LINE TO THE NORTH LINE OF LOT 2 IN BLOCK 25 OF SAID EAST FORT DES MOINES; THENCE SOUTHWEST ALONG THE NORTH LINE OF SAID LOT 2 TO NORTHWEST CORNER OF SAID LOT 2: THENCE SOUTHEAST ALONG A STRAIGHT LINE TO A POINT, SAID POINT BEING 196.1 FEET EAST FROM AND PERPENDICULAR TO THE EAST RIGHT OF WAY LINE OF EAST 7TH STREET AND BEING 237.21 FEET NORTH FROM AND PERPENDICULAR TO THE NORTH RIGHT OF WAY LINE OF LYON STREET; THENCE NORTHEAST ALONG A LINE THAT IS PARALLEL TO THE SOUTH LINE OF LOTS 3, 2 AND 1, BLOCK O, GRIFFITHS' ADDITION NO.2 TO THE TOWN OF EAST FORT DES MOINES, POLK COUNTY, IOWA, AN OFFICIAL PLAT, TO THE EAST LINE OF SAID LOT 1 AND ALONG THE NORTHEASTERLY EXTENSION OF SAID PARALLEL LINE TO THE EAST RIGHT OF WAY LINE OF PENNSYLVANIA AVENUE; THENCE SOUTH ALONG SAID EAST RIGHT OF WAY LINE OF PENNSYLVANIA AVENUE TO THE NORTHERLY RIGHT OF WAY LINE OF THE EAST/WEST ALLEY IN BLOCK P OF SAID GRIFFITHS' ADDITION NO.2 TO THE TOWN OF EAST FORT DES MOINES, POLK COUNTY, IOWA; THENCE NORTHEAST ALONG SAID NORTHERLY RIGHT OF WAY OF EAST/WEST ALLEY IN SAID BLOCK P TO THE NORTHERLY EXTENSION OF THE EAST LINE OF LOT 11 IN SAID BLOCK P; THENCE SOUTHEAST ALONG

SAID NORTHERLY EXTENSION AND ALONG THE EAST LINE OF SAID LOT 11 TO THE NORTH LINE OF THE SOUTH 90.0 FEET OF SAID LOT 11; THENCE SOUTHWEST AND PARALLEL TO THE SOUTH LINE OF SAID LOT 11 TO THE WEST LINE OF THE EAST 42.0 FEET OF SAID LOT 11; THENCE SOUTHEAST AND PARALLEL TO THE EAST LINE OF SAID LOT 11 TO THE NORTH LINE OF THE SOUTH 59.15 FEET OF SAID LOT 11; THENCE SOUTHWEST AND PARALLEL TO THE SOUTH LINE OF LOTS 11 AND 10 OF SAID BLOCK P TO SAID EAST RIGHT OF WAY LINE OF PENNSYLVANIA AVENUE AND ALONG SOUTHWESTERLY EXTENSION OF SAID LINE BEING PARALLEL TO THE SOUTH LINE OF SAID LOT 10 TO THE CENTERLINE OF PENNSYLVANIA AVENUE; THENCE SOUTH ALONG SAID CENTERLINE OF PENNSYLVANIA AVENUE AND ALONG THE CENTERLINE OF EAST 7TH STREET RIGHT OF WAY AND ALONG SAID CENTERLINE OF SOUTHEAST 7TH STREET RIGHT OF WAY TO THE POINT OF BEGINNING.

- Sec. 3. It is hereby found and determined that all of the property within the District is similarly related so that the present and potential use or enjoyment of the property is benefitted by the condition, performance of administration, redevelopment, revitalization and maintenance of the District and the owners of property in the District have a present and potential benefit from the condition, performance of administration, redevelopment, revitalization and maintenance of the District.
- Sec. 4. Pursuant to the provisions of the Act, the self-supported municipal improvement district operation fund with respect to the District known as the "Downtown Des Moines Self-Supported Municipal Improvement District Operation Fund" (herein the "Operation Fund") established and created pursuant to Ordinance 13,579, continued pursuant to Ordinance No. 13,913, continued pursuant to Ordinance No. 14,311, continued pursuant to Ordinance No. 15,218, and continued pursuant to Ordinance No. 15,700 until June 30, 2024, is hereby further continued, for which the City may certify taxes (the "Operation Tax") against the property, as defined in the Act (excluding property assessed as residential property for property tax purposes), within the District (the "Property") each year, in addition to all other taxes, commencing with the levy of taxes for collection in the fiscal year beginning July 1, 2024 and continuing for nine (9) additional years for the purposes of paying the administrative expenses of the District, as defined and authorized in the Act or paying part or all of the maintenance expenses of "improvements" or "self-liquidating improvements", as defined in the Act for a period of ten (10) years.
- Sec. 5. The City may continue to disburse the amounts collected in the Operation Fund, in accordance with the recommendations made to the City Council by the Downtown Des Moines Self-Supported Municipal Improvement District, an Iowa nonprofit corporation, for one or more of the following purposes:
 - a. Enhanced maintenance, cleaning and upkeep of public spaces within the District.
 - b. Graffiti removal on public property and private buildings within the District.

- c. Enhanced public and property safety and crime prevention within the District, including the operation of a "Goodwill Ambassador" program as determined and operated from time to time by the Downtown Des Moines Self-Supported Municipal District.
- d. Development, marketing, promotion and management of activities and events within the District.
- e. Capital, physical or other improvements designed to enhance the image and appearance of the District, including but not limited to improvements to the skywalk system.
- f. Management and operation of public spaces within the District, including public parking facilities.
- g. Research and planning services benefiting the District.
- h. Parking and transportation management benefiting the District.
- i. Activities and operations benefiting the District under any agreements with the City of Des Moines or other public or quasi public entities.
- j. Recommendations regarding, and the promotion of, the District and the advancement of the District, including with respect to the use of public spaces within the District, the types of public spaces and services within the District, the services and improvements within the District, policies and practices for the District, business retention and attraction within the District, and activities and events within the District.
- k. Other activities intended to benefit or further the purposes or interests of the District and the development and advancement of the District.
- Sec. 6. The rate of the Operation Tax to be levied annually, in addition to all other taxes, as aforesaid, shall not exceed a rate of two dollars and twenty-five cents (\$2.25) per thousand dollars of taxable value of the Property.
- Sec. 7. The invalidity of any section, clause, sentence, or provision of this ordinance shall not affect the validity of any other part of this ordinance, which shall be given effect without such invalid part or parts.
- Sec. 8. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
- Sec. 9. The City Clerk is hereby authorized and directed to cause a certified copy of this ordinance to be recorded in the office of the Polk County Recorder, and a copy thereof to be filed with the Polk County Auditor.
