ORDINANCE NO.	

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1547.01, 114-2055, 114-2159, 114-2837, 114-328.01, 114-3222, 114-3331, and 114-3744, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by Sections 114-1547.01, 114-2055, 114-2159, 114-2837, 114-328.01, 114-3222, 114-3331 and 114-3744, relating to traffic and vehicle regulations, as follows:

Sec. 114-1547.01. East University Avenue.

East University Avenue, on the north side, at a point 113 feet west of East Fifteenth Street, school signal.

East University Avenue, on the north side, at East Seventeenth Street, pedestrian signal.

Sec. 114-2055. Twenty-first Street.

Twenty-first Street, at Carpenter Avenue, stop (eastbound).

Twenty-first Street, at Carpenter Avenue, yield (westbound).

Twenty-first Street, at Drake Park Avenue, stop.

Twenty-first Street, from the north line of University Avenue to the south line of Forest Avenue, stop.

Sec. 114-2159. Carpenter Avenue.

Carpenter Avenue, at Sixteenth Street, stop.

Carpenter Avenue, from the west line of Twenty-first Street to the east line of Twenty-fourth Street, stop.

Carpenter Avenue, from the west line of Twenty-fourth Street to the west line of Twenty-sixth Street, stop.

Carpenter Avenue, at Twenty-first Street, yield (northbound).

Sec. 114-2837. East Twenty-sixth Street--East Court Avenue to East Madison Avenue.

East Twenty-sixth Street, on the west side, from Dean Avenue to Logan Avenue, no parking any time.

East Twenty-sixth Street, on the east side, from Dean Avenue to a point 200 feet north of East University Avenue, no parking any time.

East Twenty-sixth Street, on the west side, from East Grand Avenue to a point 75 feet north thereof, no parking any time.

East Twenty-sixth Street, on the west side, from a point 75 feet north of East Grand Avenue to a point 50 feet south of East Grand Avenue, no parking any time.

East Twenty-sixth Street, on the west side, from East University Avenue to a point 250 feet south thereof, no parking any time.

East Twenty-sixth Street, on the west side, from State Avenue to a point 420 feet north of Garfield Avenue, no parking any time.

East Twenty-sixth Street, on the east side, from Easton Boulevard to a point 580 feet south thereof, no parking any time.

East Twenty-sixth Street, on the west side, from Easton Boulevard to a point 75 feet south thereof, no parking any time.

East Twenty-sixth Street, on the west side, from Hull Avenue to East Euclid Avenue, no parking any time.

East Twenty-sixth Street, on the east side, from a point 75 feet south of Wedgewood Road to East Euclid Avenue, no parking any time.

East Twenty-sixth Street, on both sides, from East Euclid Avenue to East Douglas Avenue, no parking any time.

East Twenty-sixth Street, on the west side, from East Garden Avenue to East Madison Avenue, no parking any time.

East Twenty-sixth Street, on the east side, from East Garden Avenue to a point 50 feet north thereof, no parking any time.

East Twenty-sixth Street, on the east side, from East Madison Avenue to a point 45 feet south thereof, no parking any time.

Sec. 114-328.01. Pedestrian Safety, Use of Medians.

(b) For streets with a speed limit of 30 miles per hour or higher, pedestrians are prohibited from standing, sitting or staying on a median for any purpose other than to cross the street unless the width of the top surface of the median, excluding the curbs is at least 6 feet wide. This prohibits pedestrians from standing, sitting or staying on a median at the following intersections in the city:

E Army Post Rd and Southeast Wubbzy St E Army Post Rd and SE 14th St E Army Post Rd and SE Widget Rd

Mulberry Street and 8th Street Mulberry Street and 9th Street

Sec. 114-3222. East Garden Avenue--East Twenty-sixth Street to East Forty-second Street.

East Garden Avenue, on the south side, from East Twenty-sixth Street to East Twenty-seventh Street, no parking any time.

East Garden Avenue, on the north side, from East Twenty-sixth Street to a point 95 feet east thereof, no parking any time.

East Garden Avenue, on the south side, from East Fortieth Street to East Forty-second Street, no parking any time.

Sec. 114-3331. Hull Avenue--East Fourteenth Street to the dead end east of East Forty-third Court.

Hull Avenue, on the north side, from East Fourteenth Street to a point 60 feet east of Villa Vista Drive, no parking any time.

Hull Avenue, on the south side, from a point 50 feet west of East Twenty-sixth Street to a point 50 feet east of East Twenty-sixth Street, no parking any time.

Hull Avenue, on the north side, from East Twenty-ninth Street to a point 100 feet west thereof, no parking any time.
