WHEREAS, on October 23, 2023, under Roll Call No. 23-1403, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2024 Traffic Signal Replacement Contract 1, Activity ID 042022022

The improvement includes the replacement of the traffic signals at two locations, replacement of banner arms in two locations, construction of Portland Cement Concrete (PCC) curb and gutter, PCC sidewalk, traffic signals, traffic signs, pavement markings, and other incidental items, all in accordance with the contract documents, including Plan File No. 657-165/191, located at 6th Avenue and Center Street, SE 6th Street near East Granger Avenue, Court Avenue District, Western Gateway District, and other locations directed by the Engineer in Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, in accordance with said notice, those interested in said proposed plans, specifications, form of contract documents, and Engineer's estimate of construction cost both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That upon due consideration of the facts, and any and all statements of interested persons, any objections to the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement are overruled and the hearing is closed and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved.

BE IT FURTHER RESOLVED: That sealed bids for said improvement were submitted by the following bidders: Kline Electric, Inc. d/b/a Heartland Underground Solutions, Des Moines, IA - Low Bid Van Maanen Electric, Inc., Newton, IA Iowa Signal, Inc., Grimes, IA TK Concrete, Inc., Pella, IA

which were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on November 07, 2023. Said bids and the attached tabulation of bids for said improvement be and are hereby received and filed.

BE IT FURTHER RESOLVED: That the City Council hereby authorizes the necessary closure of all public grounds, streets, sidewalks, alleys, bridges, culverts, overpasses, underpasses, grade crossing separations and approaches, public ways, squares, and commons for the Project.
