## RESOLUTION AUTHORIZING BIDDING AT SHERIFF'S SALE (1401 E. 12<sup>TH</sup> STREET)

WHEREAS, the City of Des Moines filed a nuisance abatement action against Olivet University in Polk County Case No. EQCE077953 (the "Action"); and

WHEREAS, in 2016, the City obtained judgment in the Action against Olivet University for costs associated with the nuisance abatement, including demolition, court costs, and interest; and

**WHEREAS**, as a result of the final district judgment in the Action, a lien encumbering the real property located at 1401 E 12<sup>th</sup> Street in the Capital Park Neighborhood in Des Moines ("Property") was created by operation of law in the amount of the judgment and costs; and

WHEREAS, in 2023, the City initiated efforts to collect the unpaid judgment in the Action by way of special execution against the Property; and

**WHEREAS**, an execution on the judgment has issued and the Polk County Sheriff's Department has set Tuesday, January 9<sup>th</sup>, 2024, as the date of the Sheriff's sale for the Property; and

WHEREAS, the City's Neighborhood Services and Development Services staff have identified that it is in the City's best interests to attempt to acquire the property at the Sheriff's sale and collaboratively work with the community for the redevelopment of the site for missing middle housing, which will include a mix of market rate and affordable units; and

WHEREAS, the auction price for the Property may exceed the amount of the City's judgment lien which would require the City to bid additional consideration beyond the amount of its lien in order to acquire the Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Manager or his designee, subject to approval by the Legal Department is authorized and directed to represent the City's interest in acquisition of the property and bid in an amount not to exceed the amount authorized during closed session in order to acquire the property locally known as 1401 E 12<sup>th</sup> Street, Des Moines and legally described as follows:

LOTS 175, 176, 177, 178, 179, 180, 181, 182, 247, 248, 249, 250, 251, 252, 253 AND 254 IN CAPITAL PARK, AN OFFICIAL PLAT AND ALL THAT PART OF THE VACATED NORTH-SOUTH ALLEY LYING BETWEEN EAST  $12^{\rm TH}$  STREET AND EAST  $13^{\rm TH}$  STREET, EXTENDING FROM THE NORTH LINE OF CLEVELAND
