## RESOLUTION RELEASING SUBDIVISION BOND FOR WOODS ON THE RIVER PLAT 10

WHEREAS, on June 24, 2019, by Roll Call Number 19-0987 the City Council approved the subdivision bond for the development entitled Woods on the River Plat 10, located in the vicinity of Whispering Ridge Drive and River Ridge Road, to be developed by Hubbell Realty Company, Caleb Smith, Authorized Agent, and accepted bond number IAC589098 from Merchants Bonding Company, to secure the satisfactory completion and payment of the required sidewalk improvements and as-built survey costs; and,

WHEREAS, the City Engineer has certified that the sidewalk improvements and as-built survey have been completed and recommends that the security be released;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That Subdivision Bond number IAC589098 in the amount of \$90,735.00 from Merchants Bonding Company, is hereby released as security for the satisfactory completion of the sidewalk improvements and as-built survey costs.
