RESOLUTION APPROVING THE PURCHASE OF FIFTY-ONE BALLASTIC HELMETS AND PROTECTIVE BODY PANELS FROM STREICHER'S POLICE EQUIPMENT, APPROVING USE OF THE STATE OF IOWA PARTICIPATING ADDENDUM AND THE NASPO VALUEPOINT MASTER AGREEMENT NO.164720

WHEREAS, the Police Department has requested the Finance Department's Procurement Division issue a purchase order for the purchase of fifty-one (51) ballistic helmets and protective body panels for use by the members of the statewide Explosive Ordnance Detection (EOD) taskforce teams.; and

WHEREAS, the Procurement Administrator has determined that the requested Ballistic Helmets and Protective Body Panels have been competitively bid and are available from Safariland, LLC, through its authorized distributor Streicher's Police Equipment (10911 Hwy 55, Plymouth, MN 55441, Jeremy Jenniges, President), using the State of Iowa Participating Addendum and the NaspoValue Point Master Agreement No. 164720: and

WHEREAS, Municipal Code section 2-726 provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, such as Sourcewell, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the fifty-one (51) ballistic helmets and protective body panels are being purchased from Streicher's Police Equipment in the amount of \$162,154.50 utilizing the State of Iowa Participating Addendum and the NaspoValue Point Master Agreement No. 164720; and

WHEREAS, funding is available from 2023 EOD Homeland Security Grant, Special Revenue, and other funding of the 2024 Operating budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of fifty-one (51) ballistic helmets and protective body panels are being purchased from Streicher's Police Equipment in the amount of \$162,154.50 and per the terms and pricing of the State of Iowa Participating Addendum and the NaspoValue Point Master Agreement No. 164720 for use by the Police Department, is hereby approved.
