Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-670 and 114-671, relating to changes of rates for the surface parking lots at 1300 Locust Street and 1290 Walnut Street, as follows:

Sec. 114-670. Repealed by Ord. No. 15,0091300 Locust Street.

Paid parking from 9 a.m. to 9 p.m., Monday through Saturdays at a rate of \$1.00 per hour. Free parking during all other hours. The charge for prepaid special events is \$5.00 to \$10.00 and can be adjusted in accordance with Municipal Code Section 114-666 in Division 5.
