RESOLUTION RELEASING SUBDIVISION BOND FOR ELEVATE TOWNHOMES PLAT 1

WHEREAS, on April 18, 2022, by Roll Call Number 22-0594 the City Council approved the subdivision bond for the development entitled Elevate Townhomes Plat 1, located in the vicinity of the 550 Indianola Avenue, to be developed by Elevate Townhomes LLC, Adam Sieren, Authorized Agent, and accepted bond number NIA3990 from Merchants Bonding Company, to secure the satisfactory completion and payment of the required sidewalk improvements and site stabilization; and,

WHEREAS, the City Engineer has certified that the sidewalk improvements and site stabilization have been completed and recommends that the security be released;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That Subdivision Bond number NIA3990 in the amount of \$29,933.25 from Merchants Bonding Company, is hereby released as security for the satisfactory completion of the sidewalk improvements and site stabilization.
