HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR THE VACATION OF A PORTION OF THE DES MOINES MASONIC CEMETERY, LOCATED SOUTHWEST AND INTERIOR TO THE INTERSECTION OF 48<sup>TH</sup> STREET AND FRANKLIN AVENUE, AND CONVEYANCE TO CHILDSERVE HABILITATION CENTER, INC. FOR THE PURCHASE PRICE FOR \$600,000.00.

**WHEREAS**, the City of Des Moines owns numerous municipal cemeteries which are operated by the Park and Recreation Department; and

WHEREAS, on March 10, 2023, the Des Moines Masonic Cemetery Association Board of Directors passed a resolution to transfer ownership and control of the Des Moines Masonic Cemetery, located at 1550 48<sup>th</sup> Street in Des Moines, and all remaining funds in the Des Moines Masonic Cemetery operating account, after all payment of all outstanding costs and expenses, and all operations and business records and intangibles, to the City of Des Moines: and

WHEREAS, on July 17, 2023, by Roll Call No. 23-0982, the City Council approved an asset purchase agreement and offer to purchase for the transfer of ownership and control of the Des Moines Masonic Cemetery from the Des Moines Masonic Cemetery Association to the City of Des Moines, Iowa, pursuant to Deed filed and recorded in the Polk County Recorder's office on January 31, 2024, in Book 19708, Page 520, and further dedicated said property as parkland; and

WHEREAS, the City of Des Moines has received an offer from ChildServe Habilitation Center, Inc., for \$600,000.00, to acquire approximately five (5) acres of the recently acquired 40 acres transferred from the Des Moines Masonic Cemetery Association to the City of Des Moines; and

WHEREAS, there is no known current or future public need for the cemetery land proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property; and

WHEREAS, on February 5, 2024, by Roll Call No. \_\_\_\_\_\_\_\_, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed vacation and conveyance of the Cemetery parkland be set for hearing on February 19, 2024, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to vacate and convey the cemetery parkland was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
