AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2776, 114-3291, 114-3353, 114-3617, 114-3651, and 114-3753, and adding Section 114-3238.5, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by Sections 114-2776, 114-3291, 114-3353, 114-3617, 114-3651, and 114-3753, and adding Section 114-3238.5, relating to traffic and vehicle regulations, as follows:

### Sec. 114-2776. East Seventeenth Street--Dean Avenue to East Aurora Avenue.

East Seventeenth Street, on the west side, from Dean Avenue to Lyon Street, no parking any time.

East Seventeenth Street, on the east side, from a point 50 feet south of East Walnut Street to a point 50 feet north of East Walnut Street, no parking any time.
