AUTHORIZING AND APPROVING AGREEMENT WITH MCGOUGH CONSTRUCTION CO., LLC FOR CONSTRUCTION MANAGER AT RISK SERVICES FOR THE CITY FACILITY EXPANSION PHASE 1 IMPROVEMENTS, WITH PRE-CONSTRUCTION SERVICES, NOT TO EXCEED \$71,120

WHEREAS, on June 14, 2022, the Governor of Iowa signed SF 183 which created Chapter 26A of the Iowa Code, Guaranteed Maximum Price Contracts, allowing for a governmental entity to follow the process set out in Chapter 26A to select a construction manager at risk for the construction of public improvements and providing for a guaranteed maximum price; and

WHEREAS, on October 2, 2023, the City Council authorized issuance of a Notice of Intent (NOI) to Enter into a Guaranteed Maximum Price Contract for the City Facility Expansion Phase 1 Improvements, including the City's selection criteria and further authorized staff to proceed in accordance with Chapter Iowa Code Chapter 26A, including issuing Request for Qualifications (RFQ), and Request for Proposals (RFP) to procure a Construction Manager at Risk (CMR), for the City Facility Expansion Phase 1 Improvements, including the process of securing a guaranteed maximum price contract in accordance with Chapter 26A of the Iowa Code for recommendation to the City Council; and

WHEREAS, following the requirements of Chapter 26A, staff prepared and issued a Notice of Intent (NOI), Request for Qualifications (RFQ), and Request for Proposals (RFP) to procure a Construction Manager at Risk (CMR) process for the City Facility Expansion Phase 1 Improvements and the selection committee evaluated responses to the RFQ and RFP in accordance with criteria set forth therein and interviewed three firms; and

WHEREAS, the selection committee has selected and recommends the proposal submitted by McGough Construction Co., LLC for Construction Manager-At-Risk Services for the City Facility Expansion Phase 1 Improvements and

WHEREAS, the City and McGough Construction Co., LLC have negotiated the terms of a contract for CMR Services which includes the following terms:

(A) Pre-construction services shall be performed at a cost not to exceed \$71,120; and

(B) The intent, but not the right, on completion of the construction design documents, for McGough Construction Co., LLC to provide construction services for the City Facility Expansion Phase 1 Improvements under a Guaranteed Maximum Price (GMP) in accordance with the contract documents, such GMP not to be binding on the Authority until approved by the City Council.

- 2. That the contract shall be subject to review and approval prior to the City entering into a GMP Amendment for the construction phase of the City Facility Expansion Phase 1 Improvements.
