## ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-3387 and 114-3397, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-

3387 and 114-3397, relating to traffic and vehicle regulations, as follows:

## Sec. 114-3387. East Lacona Avenue--Southeast Sixth Street to dead end east of Southeast Nineteenth Street.

East Lacona Avenue, on the north side, from Southeast Sixth Street to Southeast Seventh Street point 85 feet east thereof, no parking any time.

East Lacona Avenue, on the south side, from Southeast Sixth Street to a point 45 feet east thereof, no parking any time.

East Lacona Avenue, on the south side, from a point 60 feet west of Southeast Seventh Street to a point 50 feet east of Southeast Seventh Street, no parking any time.

East Lacona Avenue, on the north side, from a point 50 feet west of Southeast Seventh Street to a point 60 feet east of Southeast Eighth Street, no parking any time.

East Lacona Avenue, on the north side, from a point 60 feet west of Southeast Eighth Street to a point 50 feet east of Southeast Eighth Street, no parking any time.

East Lacona Avenue, on the south side, from a point 60 feet west of Southeast Eighth Court to a point 50 feet east of Southeast Eighth Court, no parking any time.

East Lacona Avenue, on the north side, from a point 50 feet west of Southeast Tenth Street to a point 60 feet east of Southeast Tenth Street, no parking any time.

East Lacona Avenue, on the south side, from a point 335 feet west of Southeast Fourteenth Street to a point 165 feet east thereof, no parking any time.

East Lacona Avenue, on the north side, from a point 50-120 feet west of Southeast Fourteenth Street to a point 630 feet east of Southeast Seventeenth Street, no parking any time.

East Lacona Avenue, on the south side, from a point  $\frac{50-75}{5}$  feet west of Southeast Fourteenth Street to a point 365 feet east of Southeast Fourteenth Street, no parking any time.

East Lacona Avenue, on the south side, from Southeast Eighteenth Street east to and including the cul-de-sac, no parking any time.

## Sec. 114-3397. Lawnwoods Drive--Douglas Avenue to Hillcrest Drive.

Lawnwoods Drive, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Lawnwoods Drive, on the west side, from Douglas Avenue to Lawnviews Drive, no parking any time.

Lawnwoods Drive, on the west side, from Aurora Avenue to the dead end north thereof, no parking any time.

Lawnwoods Drive, on the east side, from the dead end south of Twana Drive to Hillcrest Drive, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
