SET HEARING FOR APPROVAL OF DOCUMENTS FOR ISSUANCE OF A REPLACEMENT QUIT CLAIM DEED CONVEYING VACATED ALLEY RIGHT-OFWAY LOCATED AT 2814 $7^{\rm TH}$ STREET TO COLD STORAGE REHAB, LLC

WHEREAS, on March 4, 1912, the City Council of the City of Des Moines, Iowa passed Ordinance No. 1903 vacating all of the alley right-of-way in the block bounded by New York Avenue and Corning Avenue and Seventh and Eighth Street, except the east 110 feet of the east-west alley (hereinafter "Property"); and

WHEREAS, at that same meeting on March 4, 1912, the City Council of the City of Des Moines, Iowa authorized and directed the Mayor, James R. Hanna, to execute a quit claim deed conveying to Consumers Ice Company, an Iowa corporation, all of the alley right-of-way vacated by Ordinance No. 1903; and

WHEREAS, no record exists of said deed being filed of record with the Polk County Recorder; and

WHEREAS, Cold Storage Rehab, LLC, successor in interest to Consumers Ice Company located at 2814 7th Street, has asked the City of Des Moines to issue a Replacement Quit Claim Deed conveying the vacated alley in the block bounded by New York Avenue and Corning Avenue and Seventh and Eighth Street to them in order to clear title to their property; and

WHEREAS, there is no known current or future public need or benefit for the City Property proposed to be conveyed, and the City will not be inconvenienced by issuing a Replacement Quit Claim Deed conveying the Property to Cold Storage Rehab, LLC.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council of the City of Des Moines, Iowa, proposes to issue a Replacement Quit Claim Deed for the vacated alley right-of-way in the block bounded by New York Avenue and Corning Avenue and Seventh and Eighth Street, except the east 110 feet of the east-west alley, as legally described below, to Cold Storage Rehab, LLC:
