**APPROVING COMPLETION AND ACCEPTANCE OF THE
POLK COUNTY PROJECT RECONSTRUCTING
BEAVER AVENUE FROM AURORA AVENUE TO
NORTHWEST LOWER BEAVER AVENUE**

WHEREAS, on April 11, 2011 under Roll Call No. 11-0566, the City Council approved execution of an agreement for Cooperative Public Service between Polk County and the City of Des Moines for the reconstruction of Beaver Avenue from Aurora Avenue to Northwest Lower Beaver Avenue since a portion of the roadway is in the boundary between the City Corporate Limits and unincorporated Polk County requiring improvements to be developed in a coordinated manner; and

WHEREAS, Polk County is the lead agency for the project including construction and the Agreement requires the City to reimburse the County the agreed upon share amount for the construction costs and the County is to provide written notice of project completion to the City declaring and certifying the improvements have been completed and constructed in substantial conformance with the plans and specifications and that all construction contracts have been paid in full and the County is to recommend final acceptance of the improvements by the City; and

WHEREAS, the City of Des Moines has reimbursed Polk County the agreed upon construction share amount of \$526,203, and Polk County has provided written notice of project completion to the City declaring and certifying the improvements have been completed and constructed in substantial conformance with the plans and specifications and that all construction contracts have been paid in full and Polk County has recommended final acceptance of the improvements by the City.
