
WHEREAS, the City Council has heretofore, by Roll Call No. 06-1470 approved on July 24, 2006, authorized the issuance of \$9,210,000 General Obligation Bonds, Series 2006B, dated August 15, 2006 (the "Series 2006B Bonds"); and

WHEREAS, the Series 2006B Bonds maturing after June 1, 2014 may be called for redemption and paid before maturity on said date or any date thereafter, from any funds regardless of source, in whole or from time to time in part, upon giving notice in the manner provided in the foregoing resolution authorizing the issuance of the Series 2006B Bonds; and

WHEREAS, it is deemed necessary and advisable that the Series 2006A Bonds and the Series 2006B Bonds be so redeemed and that notices of redemption be given.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

Section 1. That outstanding General Obligation Bonds, Series 2006A, dated August 15, 2006, in the principal amount of \$14,695,000, be and the same are hereby redeemed as of June 1, 2014.

Section 2. That outstanding General Obligation Bonds, Series 2006B, dated August 15, 2006, in the principal amount of \$7,090,000, be and the same are hereby redeemed as of June 1, 2014.

Section 3. The Finance Director/Treasurer is hereby authorized and directed to cause to be deposited in a separate fund, from the proceeds of the General Obligation Refunding Bonds, Series 2013B, dated the date of delivery, an amount sufficient to pay all principal of the redeemed Series 2006A Bonds and the Series 2006B Bonds on the date of redemption.


