SET HEARING FOR CONVEYANCE OF PROPERTY LOCATED AT 1349 WASHINGTON AVENUE TO NFC PROPERTIES, LLC FOR \$18,000

WHEREAS, the Des Moines Independent Community School District ("School District") is the owner of real property located at 1349 Washington Avenue ("Property"); and

WHEREAS, on August 26, 2103, by Roll Call No. 13-1311, the City Council approved the acceptance of real estate documents from the School District for the Property; and

WHEREAS, City staff distributed a Request for Proposal ("RFP") to developers certified with the City's Neighborhood Stabilization Program for redevelopment of the Property, with NFC Properties, LLC ("NFC") being the only respondent; and

WHEREAS, pursuant to the RFP, NFC has offered to the City \$18,000 for the purchase of the real Property, subject to restrictive covenants to ensure compliance with CDBG requirements; and

WHEREAS, if approved, the proposed conveyance of the Property by the City to NFC will be subject to the following: (1) Closing on the Property with the School District; (2) closing with NFC will occur immediately upon and following closing with the School District; (3) certain terms and conditions between the City and NFC, including acceptance of the Property "as-is, where-is" without warranty as to condition or title and release of claims related to the Property, which will be included in a development agreement between the City and NFC approved by City Council.

WHEREAS, there is no known current or future public need or benefit for the Property to be sold, and the City will not be inconvenienced by the sale of the Property subject to the terms and conditions set forth herein.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City of Des Moines, Iowa proposes to convey real property located at 1349 Washington Avenue, Des Moines, legally described as follows, to NFC Properties LLC for \$18,000 and with closing subject to the terms and conditions set forth above herein:

Lot 12 Ingle-Wold, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

2. A public hearing will be held on September 9, 2013 at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above described proposal and any other(s) submitted prior to or during the public hearing.
