WHEREAS, as described in the attached Council Communication, the proposal from EMC Risk Services, LLC, Bruce Kelley, CEO, 717 Mulberry St., Des Moines, Iowa, submitted the winning proposal with fees estimated at \$470,000.00 per annum representing an approximate savings of \$60,000.00 over previous years; and

WHEREAS, the fees are guaranteed to stay the same through the initial term and for three one year renewal if the City should elect to renew.
