APPROVING OPERATIONAL ANALYSIS SERVICES AGREEMENT WITH NAN MCKAY & ASSOCIATES, INC.

WHEREAS, the Des Moines Municipal Housing Agency (DMMHA) ("Agency") administers Public Housing, Section 8 Housing Choice Vouchers and a Family Self-Sufficiency Program, which are funded by the United States Department of Housing and Urban Development (HUD); and

WHEREAS, the Agency has sustained significant funding cuts due to reduced proration from HUD and sequestration, impacting the Agency's ability to maintain service levels; and

WHEREAS, The City of Des Moines Procurement Officer has issued Requests for Proposals, RFP V13-094 "Operational Analysis Services", on behalf of the DMMHA to study the Agency's structure; and

WHEREAS, the approved consulting service shall analyze the Agency's organizational structure to identify optimal staffing requirements to accomplish the Agency's goals and to evaluate the Agency's procedures and policies to most efficiently accomplish required functions; and

WHEREAS, Seventeen (17) proposals were issued and two (2) responses received, with Nan McKay & Associates, Inc. (Nan McKay President, 1855 Gillespie Way, El Cajon, California, 92020) receiving the highest score from the Review Selection Committee.

NOW, THEREFORE, BE IT RESOLVED, by the Municipal Housing Governing Board of the City of Des Moines, Iowa, that the Operational Analysis Services Agreement by and between the Des Moines Municipal Housing Agency and Nan McKay & Associates, Inc. is hereby approved and that the Mayor is hereby directed to execute that agreement.
