AUTHORIZING DES MOINES MUNICIPAL HOUSING AGENCY TO PROCEED WITH MODERNIZATION OF ROYAL VIEW MANOR AND SUBMIT FORMAL REQUEST TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO PAY FOR THE SAME

WHEREAS, the Des Moines Municipal Housing Agency (DMMHA) administers Public Housing, Section 8 Housing Choice Vouchers and a Family Self-Sufficiency Program, which are funded by the United States Department of Housing and Urban Development (HUD); and

WHEREAS, the DMMHA owns and operates Royal View Manor (1101 Crocker) a nine-story 200 unit apartment complex that was constructed in 1973; and

WHEREAS, the DMMHA has determined that modernization of Royal View Manor is needed to maintain its occupancy rates; improve security, improve functional use of space and enhance the quality of the physical living conditions for the residents of Royal View Manor; and

WHEREAS, the DMMHA received approval from the U.S. Department of Housing and Urban Development to hire an architectural firm to establish conceptual design and cost estimates to modernize Royal View Manor; and

WHEREAS, Wells + Associates has completed their initial conceptual design and cost estimates with an estimated amount of \$2.5 million for said modernization; and

WHEREAS, on September 23, 2013, the Housing Services Director provided an overview of the modernization plans at the Des Moines City Council workshop; and

WHEREAS, Municipal Housing Governing Board determines that it is appropriate to authorize the DMMHA to proceed with development of construction/bid documents for the modernization of Royal View Manor; and

WHEREAS, funding for this modernization would come from the DMMHA's Disposition fund upon approval from the U.S. Department of Housing and Urban Development (HUD).


