SET HEARING FOR VACATION OF A SEGMENT OF 45th STREET RIGHT-OF-WAY IN THE VICINITY OF 4421 FRANKLIN AVENUE, AND CONVEYANCE OF A PORTION THEREOF TO DAVID A. WRIGHT TRUST AND KATHERINE N. SIRCY TRUST FOR \$200, AND CONVEYANCE OF A PORTION THEREOF TO MARY BETH ANZIVINO FOR \$200

WHEREAS, on September 23, 2013, by Roll Call No. 13-1471, the City Council received a recommendation from the City Plan and Zoning Commission that a segment of 45th Street right-of-way in the vicinity of 4421 Franklin Avenue ("City Right-of-Way"), hereinafter more fully described, be vacated for conveyance to the adjoining property owners, subject to reservation of easements for all utilities in place until such time that they are abandoned or relocated; and

WHEREAS, David A. Wright, as Trustee of the David A. Wright Trust, and Katherine N. Sircy, as Trustee of the Katherine N. Sircy Trust, are the owners of the property locally known as 4421 Franklin Avenue that abuts the City Right-of-Way to the east thereof, and have offered to the City of Des Moines the purchase price of \$200 for the vacation and purchase of a portion of the City Right-of-Way, as legally described below, for the purpose of residential side yard expansion, which price reflects the fair market value of the property as currently estimated by the City's Real Estate Division; and

WHEREAS, Mary Beth Anzivino is the owner of the property locally known as 4501 Franklin Avenue that abuts the City Right-of-Way to the west thereof, and has offered to the City of Des Moines the purchase price of \$200 for the vacation and purchase of a portion of the City Right-of-Way, as legally described below, for the purpose of residential side yard expansion, which price reflects the fair market value of the property as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and conveyed, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a segment of 45th Street right-of-way in the vicinity of 4421 Franklin Avenue, more specifically described as follows:
