WHEREAS, in response to the Request for Proposals the City received two proposals for the provision of parking management services from ABM Parking Services, Inc. and Republic Parking System; and,

WHEREAS, the Evaluation and Selection Committee evaluated the submitted proposals and recommended the selection of ABM Parking Services, Inc. as manager of the City's parking facilities; and,

WHEREAS, an Agreement for Management Services between the City and ABM Parking Services, Inc. substantially in the form set out in the Request for Proposals has been prepared which Agreement is on file in the Office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the proposal submitted by ABM Parking Services, Inc. for the provision of municipal parking facilities management services is hereby accepted.

BE IT FURTHER RESOLVED that the Municipal Parking Facilities Agreement for Management Services between the City and ABM Parking Services, Inc. on file in the Office of the City Clerk is hereby approved and the Mayor is authorized and directed to sign the Agreement and the City Clerk is authorized and directed to attest to the Mayor's signature.
