SET HEARING FOR VACATION AND CONVEYANCE OF A DEAD END SEGMENT OF SOUTHWEST 11TH STREET SOUTH OF KIRKWOOD AVENUE TO DES MOINES INDEPENDENT COMMUNITY SCHOOL DISTRICT FOR \$1

WHEREAS, on October 7, 2013, by Roll Call No. 13-1553 the City Council received a recommendation from the City Plan and Zoning Commission that a dead end segment of Southwest 11th Street from Kirkwood Avenue to a point approximately 137 feet south of Kirkwood Avenue ("City Right-of-Way"), hereinafter more fully described, be vacated for conveyance to the adjoining property owner, subject to reservation of easements for all utilities in place until such time that they are abandoned or relocated; and

WHEREAS, the Des Moines Independent Community School District ("Des Moines Public Schools") is the owner of the real property locally known as 2600 SW 9th Street, Lincoln High School, adjoining the City Right-of-Way, and said Right-of-Way adjoins Lincoln High School's Hutchens Stadium; and

WHEREAS, Des Moines Public Schools has requested the vacation of the City Right-of-Way, and requested that the City convey said right-of-way to it in fee simple in accordance with Iowa Code Section 364.7(3) for the public purpose of property assemblage with Lincoln High School's Hutchens Stadium to allow for the stadium's bleachers that currently encroach onto the City Right-of-Way; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and conveyed, and the City will not be inconvenienced by the vacation and conveyance of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a dead end segment of Southwest 11th Street from Kirkwood Avenue to a point approximately 137 feet south of Kirkwood Avenue, more specifically described as follows:
