SET HEARING FOR VACATION AND CONVEYANCE OF A SEGMENT OF UNDEVELOPED FRANKLIN AVENUE BETWEEN 24TH DRIVE AND 26TH STREET TO ERICH J. RIESENBERG, TRUSTEE OF THE ERICH J. RIESENBERG LIVING TRUST, FOR \$375

WHEREAS, on July 29, 2013, by Roll Call No. 13-1196, the City Council received a recommendation from the City Plan and Zoning Commission that a segment of undeveloped Franklin Avenue from a point approximately 90 feet west of 24th Drive to a point approximately 25 feet east of 26th Street ("City Right-of-Way") be vacated, subject to the provision of any necessary easements for existing utilities until such time as they are relocated; and

WHEREAS, Erich J. Riesenberg, as Trustee of the Erich J. Riesenberg Living Trust dated June 8, 2002, is the owner of the real property locally known as 2519 Franklin Avenue, 2521 Franklin Avenue and Tax Parcel 080/00282-001-000 that adjoins said City Right-of-Way, and has offered to the City of Des Moines the purchase price of \$375.00 for the vacation and purchase of a fee simple interest in such excess Right-of-Way as legally described below, in order to incorporate the property into the buyer's adjoining properties, which purchase price reflects the fair market value of the City Right-of-Way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a segment of undeveloped Franklin Avenue from a point approximately 90 feet west of 24th Drive to a point approximately 25 feet east of 26th Street, more specifically described as follows:

ALL THAT PART OF FRANKLIN AVENUE RIGHT-OF-WAY LYING SOUTH OF AND ADJOINING LOTS 16 AND 17, ALICE BRIAR, AN OFFICIAL PLAT, AND LYING SOUTH OF AND ADJOINING THE WEST ½ OF LOT 4 AND ALL OF LOT 5 IN C. H. ATKIN'S SUBDIVISION OF LOT 31 OF THE OFFICIAL PLAT OF SECTION 33, TOWNSHIP 79 NORTH, RANGE 24 WEST OF THE 5TH P.M., AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

2. That if the City Council decides to vacate the above-described right-of-way, the City of Des Moines further proposes to sell such vacated right-of-way, as legally described below, to Erich J. Riesenberg, as Trustee of the Erich J. Riesenberg Living Trust Dated June 8, 2002, for \$375.00:

ALL THAT PART OF VACATED FRANKLIN AVENUE RIGHT-OF-WAY LYING SOUTH OF AND ADJOINING LOTS 16 AND 17, ALICE BRIAR, AN OFFICIAL PLAT, AND LYING SOUTH OF AND ADJOINING THE WEST ½ OF LOT 4 AND ALL OF LOT 5 IN C. H. ATKIN'S SUBDIVISION OF LOT 31 OF THE OFFICIAL PLAT OF SECTION 33, TOWNSHIP 79 NORTH, RANGE 24 WEST OF THE 5TH P.M., AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.
