## SET HEARING FOR VACATION AND CONVEYANCE OF THE NORTH 20 FEET OF RAILROAD AVENUE RIGHT-OF-WAY ADJOINING 918 SE 11<sup>TH</sup> STREET TO YOUTH EMERGENCY SERVICES AND SHELTER FOR \$6,000

WHEREAS, on October 7, 2013, by Roll Call No. 13-1560, the City Council received a recommendation from the City Plan and Zoning Commission that the north 20 feet of Railroad Avenue south of and adjoining 918 SE 11<sup>th</sup> Street ("City Right-of-Way"), hereinafter more fully described, be vacated for conveyance to the adjoining property owner, subject to reservation of easements for all utilities in place until such time that they are abandoned or relocated; and

WHEREAS, Youth Emergency Services and Shelter ("YESS") is the owner of the real property locally known as 918 SE 11<sup>th</sup> Street, which adjoins the City Right-of-Way, and has offered to the City of Des Moines the purchase price of \$6,000 for the purchase of the City Right-of-Way for incorporation into their property and redevelopment for possible setback purposes and to minimize risk of missing the current property line for footings, which purchase price reflects the fair market value of the City Right-of-Way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating the north 20 feet of Railroad Avenue south of and adjoining 918 SE 11<sup>th</sup> Street, more specifically described as follows:

THE NORTH 20 FEET OF THE EAST RAILROAD AVENUE RIGHT-OF-WAY LYING SOUTH OF AND ADJOINING BLOCK 6, ALLEN'S SECOND ADDITION TO DES MOINES, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines further proposes to sell such vacated right-of-way, as legally described below, to Youth Emergency Services and Shelter (YESS) for \$6,000, in accordance with the requirements of the Plan and Zoning Commission recommendation:

THE VACATED NORTH 20 FEET OF THE EAST RAILROAD AVENUE RIGHT-OF-WAY LYING SOUTH OF AND ADJOINING BLOCK 6, ALLEN'S SECOND ADDITION TO DES MOINES, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA
