WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and conveyed, and the City will not be inconvenienced by the vacation and sale of said property; and

WHEREAS, on September 23, 2013, by Roll Call No. 13-1472, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on October 7, 2013, at 5:00 p.m., in the Council Chamber; and
