RESOLUTION APPROVING PRELIMINARY TERMS OF AN URBAN RENEWAL DEVELOPMENT AGREEMENT WITH FORT DES MOINES RESTORATION, LLC, FOR THE HISTORIC REDEVELOPMENT OF PROPERTIES IN THE SOUTHSIDE ECONOMIC DEVELOPMENT DISTRICT URBAN RENEWAL AREA

WHEREAS, Fort Des Moines Restoration, LLC, represented by Justin Doyle, Partner, has proposed a \$26 million rehabilitation of existing buildings in Historic Fort Des Moines into 154 market rate residential units, with potential future phases of the project proposed to incorporate commercial uses following additional land and building acquisition; and,

WHEREAS, Historic Fort Des Moines is located south of Army Post Road and east of SW 9<sup>th</sup> Street, and is listed on the National Register of Historic Places; and,

WHEREAS, the Office of Economic Development has negotiated preliminary terms of agreement with Fort Des Moines Restoration, LLC, for City assistance consisting an Economic Development Grant payable in installments over 15 years with the installments in years 1 through 10 to be equal to 100% of the project generated TIF, and in years 11 through 15 to be equal to 75% of the project generated TIF, having an estimated net present value of approximately \$2,038,000, and to assist in identifying an additional financing source to fund approximately \$1 million in needed street and utility infrastructure improvements, all as more specifically described in the accompanying Council Communication.
