APPROVING THE TRESTLE TO TRESTLE MULTI-USE RECREATIONAL TRAIL MAP AND NAME

WHEREAS, trail development is a very high priority with the citizens of the City of Des Moines and the Des Moines City Council; and

WHEREAS, on January 22, 2007, by Roll Call No. 07-169, the City Council approved a 28E Agreement with the City of Johnston, Polk County and Polk County Conservation Board for the construction and maintenance of the Trestle-to-Trestle Trail, which was constructed within the City of Des Moines and also within Polk County and the City of Johnston, as a Multi-Use Recreational Trail to provide recreational and commuter opportunities; and

WHEREAS, the 28E Agreement specifies that the City shall have ownership of all Trail improvements, except for the Trail improvements within the City of Johnston; and

WHEREAS, the 28E Agreement also specifies that City of Des Moines laws and rules relating to use and operation of the Trail shall apply, except for that portion of the Trail which is within the City of Johnston; and

WHEREAS, the Multi-Use Recreational Trail Ordinance requires that trails are to be designated as a Multi-Use Recreational Trail by approval of a Map showing such trail by resolution of the City Council; and

WHEREAS, the Trestle to Trestle Multi-Use Recreational Trail Map, a copy of which is on file in the office of the City Clerk, has been prepared by the Park and Recreation Department.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Des Moines, Iowa, that the Trestle to Trestle Multi-Use Recreational Trail Map, a copy of which is on file with the office of the City Clerk, is hereby accepted and approved, and the Trail shall be designated and known as the "Trestle to Trestle Multi-Use Recreational Trail".
