WHEREAS, the City Plan and Zoning Commission has advised that at a public hearing held on October 17, 2013, its members voted 12-0-1 in support of a motion to recommend APPROVAL of a request from Loffredo Gardens, Inc. (owner), represented by Eugene Loffredo (officer), to rezone property located at 4001 Southwest 63rd Street from "PBP" Planned Business Park to "M-1" Light Industrial District to allow for an approximately 45.000-square foot warehouse building to be developed on property to the south of the existing facility, subject to the owner agreeing to the following conditions:

- 1. Permitted uses and accessory uses shall only be those in the Planned Business Park regulations in Section 134-737 and 134-738.
- 2. Vehicular driveway access for site development use may only be from Watrous Avenue
- 3. Any development of the property shall be compatible with the design of the existing warehouse and office facility on the adjoining property to the north, to include pre-cast concrete panels, metal panels with no exposed fasteners, and glass with stucco panels used only as an accent material.
- 4. Applicant shall meet with adjoining property owner to discuss provision of landscaping along the south boundary.

The subject property is more specifically described as follows:

Outlot Z. Airport Industrial Park Plat 2, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. That the meeting of the City Council at which the proposed rezoning is to be considered shall be held in the Council Chambers, City Hall, Des Moines, Iowa at 5:00 p.m. on November 18, 2013, at which time the City Council will hear both those who oppose and those who favor the proposal.
