RESOLUTION CLOSING HEARING ON REQUEST FROM RACCOON STREET WAREHOUSE, LLC, TO REZONE PROPERTY LOCATED AT 301 AND 309 SOUTHEAST 8th STREET FROM M-1 LIGHT INDUSTRIAL DISTRICT TO M-2 HEAVY INDUSTRIAL DISTRICT AND TO REMOVE THE PROPERTY FROM THE "D-O" DOWNTOWN OVERLAY DISTRICT,

WHEREAS, the City Plan and Zoning Commission has advised that at a public hearing held on August 7, 2000, its members voted 13-0 in support of a motion to recommend **DENIAL** of a request from Raccoon Street Warehouse, LLC, to rezone property located at 301 and 309 Southeast 8th Street from the M-1 Light Industrial District to the M-2 Heavy Industrial District and to remove the property from the "D-O" Downtown Overlay District, to allow for a future request for a Conditional Use to allow a beverage container recycling business; and

WHEREAS, on October 21, 2013 by Roll Call No. 1627, the City Council set a public hearing on the proposed rezoning for November 4, 2013 at 5:00 p.m. in Council Chambers, City Hall, Des Moines, Iowa;

The subject property is more specifically described as follows (the "Property"):

All Lots 1 through 10, and vacated intervening North/South alley Right-of-Way, Block 35, Town of De Moine, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

WHEREAS, notice of the public hearing was published in the Des Moines Register according to law on October 24, 2013, setting forth the time and place for hearing on the proposed rezoning; and

WHEREAS, in accordance with the notice those interested in the proposed rezoning, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to City Council.


