## APPROVING AND AUTHORIZING THE EXECUTION OF AMENDMENT TO THE CONTRACT OF PURCHASE BETWEEN NORFOLK SOUTHERN RAILWAY COMPANY AND CITY OF DES MOINES FOR THE SOUTHEAST CONNECTOR PROJECT

WHEREAS, on October 25, 2010, by Roll Call No. 10-1786, City Council authorized acquisition of the necessary right-of-way and easements for the SE Connector Project; and

WHEREAS, on August 27, 2012, by Roll Call No. 12-1328, City Council approved Department of Transportation Conditional and Preliminary Term Sheet for the TIGER Discretionary Grant for the Southeast Connector Project between SE 14<sup>th</sup> Street and SE 30<sup>th</sup> Street, which included an interim milestone of December 2012 for the Norfolk Southern Railway Company ("NSR") agreement; and

WHEREAS, on December 17, 2012, by Roll Call No. 12-1914, City Council approved and authorized execution of the Contract of Purchase between the City and NSR for the partial acquisitions, temporary construction easements, permanent easement for roadway overpass, and total fee acquisition of property owned by NSR and required for the Southeast Connector; and

WHEREAS, the City of Des Moines and NSR have negotiated an amendment to the Contract of Purchase as necessary to extend the closing date by an additional 180 days and to amend NSR's conveyance of the fee acquisition property to be completed by quit claim deed.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. That the First Amendment to Contract of Purchase between Norfolk Southern Railway Company and the City of Des Moines, in connection with the Southeast Connector Project, be and is hereby approved as substantially in the same form as on file in the office of the City Clerk, subject to approval as to form by the City Legal Department.
- 2. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said First Amendment for and on behalf of the City of Des Moines, Iowa, following approval as to form by the City Legal Department, and to return said First Amendment to the City Real Estate Division Manager for execution by Norfolk Southern Railway Company.
- 3. That the City Real Estate Division Manager is hereby authorized to administer the terms of said Contract of Purchase and First Amendment thereto, and to approve and execute further amendments or other documents pertaining to minor or unsubstantial changes to said Contract, following approval of the City's Legal Department as to form.
