**APPROVING PROFESSIONAL SERVICES AGREEMENT WITH
SHUCK-BRITSON, INC. FOR DESIGN AND
CONSTRUCTION PHASE SERVICES FOR THE
GRAND AVENUE OVER DES MOINES RIVER BRIDGE REPLACEMENT
NOT TO EXCEED \$626,169**

WHEREAS, on May 6, 2013, by Roll Call No. 13-0697, the City Council approved a Professional Services Agreement with Shuck-Britson, Inc. for evaluation, design, and construction phase services for the Grand Avenue over Des Moines River Bridge Rehabilitation not to exceed \$273,947; and

WHEREAS, Shuck-Britson, Inc. has completed the evaluation phase of the Professional Services Agreement; and

WHEREAS, the evaluation determined that the deterioration of the structural components was much more advanced than anticipated; and

WHEREAS, the consultant evaluated the initial construction costs and life cycle costs for four repair options and one replacement option, and found that initial construction costs were similar for the repair and replacement options, but that the replacement option had the lowest life cycle cost.

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the City Manager is hereby authorized and directed to terminate the Professional Services Agreement for the Grand Avenue over Des Moines River Bridge Rehabilitation.
2. That the Professional Services Agreement between the City of Des Moines and Shuck-Britson, Inc., Timothy J. Monson, President, 2409 Grand Avenue, Des Moines, Iowa, 50312, for a total cost not to exceed \$626,169, based on hourly rates, to provide design and construction phase services for the Grand Avenue over Des Moines River Bridge Replacement, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.
