APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR SIGNALIZATION IMPROVEMENTS, 602 CHERRY STREET,
BETWEEN BAKER ELECTRIC, INC. AND THE WEITZ COMPANY, LLC

WHEREAS, on July 25, 2011 under Roll Call No. 11-1273, the City Council approved a private construction contract in the amount of \$29,789.00, between Baker Electric, Inc., Britt Baker, CEO, 111 Jackson Avenue, Des Moines, IA, 50315 - as Contractor, and The Weitz Company, LLC, Leonard Martling, President, CEO, 5901 Thornton Avenue, Des Moines, IA, 50321 - as Owner, for construction of Signalization Improvements described as Remove and replace traffic signals at 6th Avenue & Cherry Street and at 7th Street & Cherry Street, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 513-072/073, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Signalization Improvements in the amount of \$29,789.00, which have been constructed in substantial compliance with the contract documents between Baker Electric, Inc. and The Weitz Company, LLC, which were approved under Roll Call No. 11-1273, dated July 25, 2011, be received and filed; and that completion of said Signalization Improvements described as Remove and replace traffic signals at 6th Avenue & Cherry Street and at 7th Street & Cherry Street, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 513-072/073, is hereby acknowledged and that said Signalization Improvements are hereby accepted.
