SETTING DATE OF PUBLIC HEARING ON THE PROPOSED FOURTEENTH AMENDMENT TO THE METRO CENTER URBAN RENEWAL PLAN

WHEREAS, on March 20, 2000, by Roll Call Nos. 00-788 and 00-789, the City Council adopted the Urban Renewal Plan for the Metro Center Urban Renewal Project, and such Plan has been amended thirteen times (the urban renewal plan as so amended is herein referred to as the "Plan"); and,

WHEREAS, the Metro Center Urban Renewal Project Area encompasses an irregularly shaped area that includes the downtown core and the areas surrounding the downtown core; and,

WHEREAS, the purpose of the proposed Fourteenth Amendment to the Plan, attached hereto as Exhibit "A", is to: (a) approve the Doyle Properties office historic rehabilitation project at 130 East 3rd Street, and the East Village Towers residential, commercial, and skilled nursing project at 600 East 5th Street and update prior approved projects; (b) update disposition parcel and public facilities and improvements maps; and (c) update the Financial Condition Report to reflect the approved projects; and,

WHEREAS, the Urban Design Review Board may review the proposed amendment at its regular meeting of February 18, 2014, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. A public hearing shall be held before the City Council to consider the proposed Fourteenth Amendment to the Plan at 5:00 p.m. on March 10, 2014, in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa.
- 2. The City Clerk is authorized and directed to publish notice of said public hearing in the form attached hereto as Exhibit "B". Said notice shall be published in the Des Moines Register on February 20, 2014.
- 3. The proposed Fourteenth Amendment is hereby submitted to the Urban Design Review Board for its review and recommendation, with said written recommendation requested to be received by the City Council prior to the date of public hearing.
