- 4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency's amended budget for fiscal year ending June 30, 2014 to the Des Moines City Council for incorporation into the City's fiscal year 2014 amended budget to be certified to the State of Iowa.
