WHEREAS, on February 24, 2014, by Roll Calls No.14-0250 and 14-0251, the Municipal Housing Governing Board set the public hearings to consider the Municipal Housing Agency's amended annual budget for all projects for the current fiscal year ending June 30, 2014 and to consider the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2015, for March 10, 2014 and public notice of such hearings was published as provided by law in the Des Moines Register on February 27, 2014; and

WHEREAS, following the respective public hearings on March 10, 2014 the Municipal Housing Governing Board approved the Municipal Housing Agency's amendment to annual budget for all projects for the current fiscal year ending June 30, 2014 by Roll Call No. 14- 0339 and approved the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2015 by Roll Call 14- 0340 ; and

WHEREAS, the Des Moines Municipal Housing Agency is required to certify approval of the operating budgets to the U.S. Department of Housing and Urban Development; and


