APPROVING AGREEMENTS WITH MIDAMERICAN ENERGY COMPANY TO REPLACE THE WOOD DISTRIBUTION POLES WITH FIBERGLASS POLES, INSTALL NEW LED STREET LIGHTS, AND TO REDUCE THE AMOUNT OF OVERHEAD WIRING FOR THE BEAVER AVENUE STREETScape, NOT TO EXCEED \$204,898.56

WHEREAS, agreements have been received from MidAmerican Energy Company, Eric Heikes, Supervisor of Electric Distribution Engineering, 10510 Douglas Avenue, Urbandale, Iowa, 50322, to replace wood distribution poles with fiberglass poles, install new LED street lights, and to reduce the amount of overhead wiring for the Beaver Avenue Streetscape which are required to be executed by the City of Des Moines.

NOW, THEREFORE, BE, AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the attached agreements between the City of Des Moines and MidAmerican Energy Company to replace the wood distribution poles with fiberglass poles, install new LED street lights, and to reduce the amount of overhead wiring for the Beaver Avenue Streetscape, for a cost not to exceed \$204,898.56, be and are hereby approved.
2. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said agreements for and on behalf of the City of Des Moines, Iowa.
