RESOLUTION AUTHORIZING SUBMISSION OF AN IOWA FLOOD MITIGATION PROGRAM JOINT APPLICATION WITH THE DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY (WRA) TO THE IOWA HOMELAND SECURITY AND EMERGENCY MANAGEMENT AGENCY, APPROVING THE PROJECT PLAN, AND APPROVING A 28E AGREEMENT BY AND BETWEEN THE CITY OF DES MOINES, IOWA AND THE DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY FOR THE JOINT APPLICATION FOR ADMINISTRATION AND FUNDING OF A PROJECT PLAN PURSUANT TO THE IOWA FLOOD MITIGATION PROGRAM

WHEREAS, the Iowa Homeland Security & Emergency Management Agency is accepting applications for the Iowa Flood Mitigation Program, pursuant to Iowa Code Chapter 418, for the use of Sales Tax Revenues to provide funding to governmental entities to implement long-term flood mitigation projects; and

WHEREAS, the City and the Des Moines Metropolitan Reclamation Authority (WRA) are planning long-term flood mitigation projects which are beneficial to both parties, including but not limited to the reduction of flood potentials for the downtown and southeast Des Moines area, the WRA System and the Wastewater Reclamation Facility (WRF), and the ability to better operate the WRF and maintain capacity in the WRA System during wet weather events; and

WHEREAS, the City and the WRA desire to submit a joint application for the Iowa Flood Mitigation Program to the Flood Mitigation Board for the use of Sales Tax Revenues under Iowa Code Chapter 418 for funding of the proposed flood mitigation projects.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That submission of a joint application between the City of Des Moines and the Des Moines Metropolitan Wastewater Reclamation Authority, in substantially the form as on file with the City Engineer, be and is hereby authorized, and that the City Engineer is hereby authorized and directed to execute said Application for and on behalf of the City of Des Moines, and submit said Application to the Iowa Homeland Security and Emergency Management Agency.
- 2. That the Iowa Flood Mitigation Project Plan prepared for the joint application, in substantially the form as on file with the City Engineer, is hereby approved, and the City Engineer is authorized and directed to submit said Plan with the Application to the Iowa Homeland Security and Emergency Management Agency.
