**APPROVING AND AUTHORIZING THE EXECUTION OF
SIEGWERK USA COMPANY GRADE CROSSING
SURFACE REPAIR PROGRAM AGREEMENT FOR
PARK AVENUE**

WHEREAS, the City of Des Moines and Siegwerk USA Company submitted a request for Iowa Grade Crossing Repair Program funds for Park Avenue (FRA No. 922305U); and

WHEREAS, the Iowa Department of Transportation, Office of Rail Transportation, has approved use of this fund for repair and improvement for Park Avenue (FRA No. 922305U). The total estimate of the project participation is \$114,406 of which the City participation is 20%, or \$22,881.20 plus participation in 100% of the traffic control estimate of \$6,820, for a final total City participation of \$29,701.20.

NOW, THEREFORE, BE, AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the agreement between the City of Des Moines and Siegwerk USA Company for Grade Crossing Surface Repair Program for Park Avenue (FRA No. 922305U) be hereby approved subject to approval by Siegwerk USA Company, and the Mayor is authorized and directed to sign such agreement, and the City Clerk to attest to the Mayor's signature, and return three original copies of the agreement to the Engineering Department for transmittal to the Iowa Department of Transportation.

IT IS FURTHER RESOLVED that the Finance Director is hereby authorized to make payment to Siegwerk USA Company for said Grade Crossing Surface Repair Program upon receipt of an invoice from Siegwerk USA Company, and approval by the City Engineer.
