## HOLD HEARING FOR CONVEYANCE OF A PORTION OF THE VACATED EAST/WEST ALLEY RIGHT-OF-WAY ADJOINING 2815 FRANKLIN AVENUE TO BEVERLY J. MUGAN FOR \$270

WHEREAS, August 23, 1999, by Roll Call No. 99-2691, City Council approved and adopted Ordinance No. 13,746 vacating the east/west alley right-of-way between Franklin Avenue and Allison Avenue, extending east from 30<sup>th</sup> Street, including the portions thereof adjoining 2815 Franklin Avenue, subject to the reservation of an easement for all utilities in place and reservation of right of entry for servicing same; and

WHEREAS, Beverly J. Mugan, owner of 2815 Franklin Avenue, has offered to the City of Des Moines the purchase price of \$270 for the purchase of the portion of the vacated alley right-of-way adjoining 2815 Franklin Avenue for incorporation into her adjoining property, which price reflects the fair market value of said portion of vacated alley right-of-way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the vacated alley right-of-way proposed to be sold and the City will not be inconvenienced by the sale of said property; and

WHEREAS, on May 5, 2014 by Roll Call No. 14-0689, it was duly resolved by the City Council that the proposed conveyance of the property be set down for hearing on May19, 2014, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to convey the vacated alley right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed conveyance of the vacated alley right-of-way as described below are hereby overruled and the hearing is closed.
- 2. There is no public need for the property described below and the public would not be inconvenienced by reason of the conveyance of the portion of the vacated east/west alley right-of-way between Franklin Avenue and Allison Avenue, extending east from 30<sup>th</sup> Street, that adjoins 2815 Franklin Avenue, as legally described below and to the grantee and for the consideration
