**APPROVAL OF AMENDMENTS TO THE DES MOINES COMMUNITY
DEVELOPMENT BLOCK GRANT--DISASTER RECOVERY (CDBG-DR)
CONTRACTS (NUMBER 08-DRH-209 and NUMBER 08-DRH-009) TO REDUCE
AWARD FOR SINGLE-FAMILY NEW CONSTRUCTION ACTIVITIES BY \$192,733**

WHEREAS, the Iowa Economic Development Authority (IEDA) administers Community Development Block Grant Disaster Recovery (CDBG-DR) funds to assist with flood recovery pursuant to a statewide allocation plan approved by the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, on October 13, 2008, by Roll Call No. 08-1809, IEDA and the City of Des Moines entered into Contract Number 08-DRH-009 for use of CDBG-DR funds, including Single-Family New Production Funds, to assist in rebuilding after the floods of 2008, which contract has been amended 12 times to incorporate additional activities and funding; and

WHEREAS, on April 20, 2009, by Roll Call No. 09-645, IEDA and the City of Des Moines entered into Contract Number 08-DRH-209 for use of CDBG-DR funds, including Single-Family New Production Funds, to assist in rebuilding after the floods of 2008, which contract has been amended 17 times to add or delete activities and funding; and

WHEREAS, single-family units constructed under Contract Number 08-DRH-009 were completed under budget, and the funding excess amount of \$72,733 must be returned to IEDA; and

WHEREAS, four single-family unit sites were not developed under Contract Number 08-DRH-209, and the funding of \$120,000 for said sites must be returned to IEDA; and

WHEREAS, IEDA has initiated amending Contract Number 08-DRH 009 and Contract Number 08-DRH-209 to reflect the decreased funding amounts, and has requested that Amendment #13 and Amendment #18 to said Contracts, respectively, be approved by the City and signed by the Mayor.

1. Amendment #13 to Contract Number 08-DRH-009 to delete \$72,733 from Single-Family Housing Activities funding, amending the total amount of said Contract from \$3,510,989 to \$3,390,980, is hereby approved.
2. Amendment #18 to Contract Number 08-DRH-209 to decrease the performance measure by four housing units and to delete \$120,000 from Single-Family Housing Activities funding, amending the total amount of said Contract from \$18,822,134 to \$18,749,401 is hereby approved.
3. The Mayor is authorized and directed to sign the Contract amendments and the City Clerk is directed to attest to his signature.
