> PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 2020 TRAFFIC SIGNAL REPLACEMENT CONTRACT 2; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS VAN MAANEN ELECTRIC, INC., NATHAN S. VAN MAANEN, PRESIDENT, \$512,624.00

WHEREAS, on January 13, 2020, under Roll Call No. 20-0013, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2020 Traffic Signal Replacement Contract 2, 04-2020-008

The improvement includes new traffic signals, vehicle loop detectors, Hot Mix Asphalt (HMA) pavement, Portland Cement Concrete (PCC) sidewalk, pavement markings, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 613-188/224, located at the intersection of Lower Beaver Road and Madison Avenue and the intersection of 19th Street and Clark Street, Des Moines, Iowa.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.
