CONTINUING HEARING FOR ADOPTION OF PROPOSED AMENDMENT TO MUNICIPAL HOUSING AGENCY ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2020.

WHEREAS, on March 9, 2020, in approving item M.H.G.B. 3A, the Municipal Housing Governing Board set A public hearing to consider the Municipal Housing Agency's proposed amendment to the annual budget for the fiscal year ending June 30, 2020 for March 23, 2020, at 4:15 o'clock p.m., in the Council Chambers in City Hall and public notice of such hearing was published as provided by law; and

WHEREAS, by a Proclamation issued March 15, 2020, Mayor Cownie determined that a state of emergency or public danger exists within the City of Des Moines as a result of the global spread of the COVID-19 virus, and declared that all gatherings of 250 people or more on public property or public right-of-way are prohibited; and,

WHEREAS, by a Proclamation of Disaster Emergency issued March 17, 2020, Governor Kimberly K. Reynolds proclaimed a State of Public Health Disaster Emergency exists throughout the entire state of Iowa, and ordered that that "Social, community, spiritual, religious, recreational, leisure, and sporting gatherings and events of more than 10 people are prohibited at all locations and venues, including but not limited to parades, festivals, conventions, and fundraisers"; and,

WHEREAS, by a Proclamation Amendment issued March 17, 2020, Mayor Cownie determined that the state of emergency or public danger determined to exist in his prior Proclamation still exists and he amended the Proclamation to prohibit all gatherings of 10 people or more on public property or public right-of-way; and,

WHEREAS, the City Council cannot hold the related budget hearings on March 23, 2020 pursuant to the Mayor's Proclamation of March 15, 2020, as amended by the Proclamation Amendment of March 17, 2020.

NOW THEREFORE, BE IT RESOLVED, by the Municipal Housing Governing Board, that the public hearing previously scheduled to be heard by the City Council on March 23rd, 2020, is continued until April 27, 2020 at 4:15 p.m. in the Richard A. Clark Municipal Services Center at 1551 East Martin Luther King Jr. Parkway, Des Moines, Iowa.
