- 2. Upon due consideration of all views and comments presented by residents and taxpayers of the City or the area of operation of the Agency, the public hearing on the Municipal Housing Agency's proposed annual budget for fiscal year ending June 30, 2021 is hereby closed.
- 3. The Municipal Housing Agency's annual budget for the fiscal year ending June 30, 2021, as set forth in the operating budget document on file with the City Clerk is hereby approved and adopted.
- 4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency's budget for the fiscal year ending June 30, 2021 to the Des Moines City Council for incorporation into the City's fiscal year 2021 budget to be certified to the State of Iowa.
